**CANCELLATION POLICY: THERE WILL BE NO REFUNDS UNLESS YOU CAN BE REPLACED BY A PARTICIPANT OF APPROPRIATE GENDER FROM A WAIT LIST. FAILURE TO MAKE PAYMENTS AS SCHEDULED WILL BE CONSIDERED CANCELLATION AND DEPOSIT PLUS OTHER NON-RECOVERABLE COSTS WILL BE FORFEITED IF NO REPLACEMENT IS FOUND.**

Membership dues are non-refundable. Travel insurance is recommended. If you have been exposed to COVID-19 or experience any medical symptoms (even slight) associated with COVID-19 you are expected to self-report to the trip coordinator and not participate in the trip.

TSA traveler information is due to the airline and tickets will be issued Jan 7, 2022. Any name or itinerary changes made after ticketing will result in \$250 fee, plus any difference in fare. ALL CHANGES MUST BE MADE 14 BUSINESS DAYS PRIOR TO FLIGHT DEPARTURE. Unused tickets are non-refundable. Discount certificates, vouchers, senior discounts and other promotional offers cannot be used in conjunction with this fare.

Group lift passes will be ordered 40 days prior to travel. Unused or partially used group lift passes accompanied by a doctor's note may be considered for refund and must be returned to Ski.com within 7 days of trip return. Any refunds will be subject to \$45 fee. Unused or partially used group lift passes without a doctor's note are non-refundable. IKON passes are non-refundable / non-transferable (pass insurance is available from IKON).

Ski.com cancellation policy: Individual cancellations received after Jan 26, 2022 will be subject to an additional \$75 processing fee. There are no refunds for unused services or early departures. I HAVE BEEN INFORMED OF CANCELLATION POLICIES AND PENALTIES AND AGREE TO THE TERMS.

**SPORT PARTICIPANT RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

*Please read and be certain you understand the implications of signing.*

Express Assumption of Risk Associated with Sport, Venue Use and Related Activities.

I, \_\_\_\_\_ do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with **FOUNTAIN VALLEY SKI CLUB** activities, transportation of equipment related to the activities, and traveling to and from activity sites in which I am about to engage. Inherent hazards and risks include but are not limited to:

1. Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and back or other bodily injuries that my result in permanent disability and death.
2. Possible equipment failure and/or malfunction or misuse of my own or others' equipment.
3. I AGREE THAT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, neck or spinal cord.
4. Variation and/or steepness of terrain, variation or changes in surfaces including but not limited to snow surfaces, ice, bare spots, rocks, stumps, debris, cliffs, trees, fences, posts, trees, light poles, signs, buildings, roads, walkways, ramps, rails, stairs, pyramids, manual pads, bowls, half-pipes, jumps, padded and nonpadded barriers, other persons, and other natural and man-made hazards.
5. My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, weather, riding surfaces or other obstacles.
6. Exposure to the elements and temperature extremes may result if frost nip, frost bite, heat exhaustion, heat stroke, sunburn, hypothermia and dehydration.
7. Dangers associated with exposure to natural elements include but are not limited to avalanche, rock fall, inclement weather, thunder and lightning, severe and or varied wind, temperature and other weather conditions.
8. Accidents or illness occurring in remote places where there are no available medical facilities.

9. Fatigue, exhaustion, chill, and/or dizziness, which may diminish my/our reaction time and increase the risk of accident.

10. Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles, and cyclists.

\*I understand the description of these risks is not complete and unknown or unanticipated risks may result in injury, illness, or death.

**1. I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, the following named persons or entities, herein referred to as releases: FOUNTAIN VALLEY SKI CLUB.**

2. To release the releasees, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise.
